**GENERAL TERMS & CONDITIONS FOR PARTICIPATING IN THE BID**

**'Supply of Healthy Live Pigs at Dimapur, Nagaland for the year 2026-27'**

**1. ELIGIBILITY CRITERIA:** Company/Firms/LLP/Proprietorship Concerns having experience in similar nature of work are eligible to participate provided they fulfil the following conditions:

- a) Experience / credential in the field of pig rearing/farming/supply for at least three years.
- b) Bidders Area of operation shall be within India
- c) Three completed orders of 30% or more value, for supply of livestock of similar nature
- d) Financial Net Worth of at least 30% of order value and solvency of at least 20% of order value, certified by a Chartered Accountant

**2. SCOPE OF WORK:** Supply of Live Pigs (On Hoofs) White Yorkshire/Blak or Hampshire cross Male or Female Pigs, meat type, weighing 80-kg to 120-kg, vaccinated, without any diseases, complete with an authorized Veterinarian Physto-Sanitary Certificate, at Dimapur, Nagaland inclusive of all transportation costs, handling costs, taxes and octroi fees. There should be no pregnant or injured animal in the entire lot.

**3.** The application along with supportive documents in **separate cover** namely Technical & Financial Cover must be submitted physically in the tender box on or before **08.02.2026 up to 05:00 PM**. Any other mode of bid submission will be summarily rejected.

**4.** The Technical Bid documents will be opened & evaluated by the Tender Selection committee of this corporation on **09.02.2026 at 11:30 AM onward**.

**5.** L<sub>1</sub> bidder among the qualified & valid participants will be awarded in due course of time.

**6.** The period of agreement will be initially for **1 year from the date of issuance of Letter of acceptance** which may further be extended up to **another 1 year** depending upon the performance of the agency.

**7.** The successful bidder will have to enter into a contractual agreement with the Corporation in the standard format (already submitted along with NIT) embodying the tender terms & conditions in Non-judicial Stamp Paper worth Rs.1000/- (Rupees One Thousand) only to be provided by the successful bidder. Prescribed Agreement must be signed also by the Authorized Signatory of the Tendering firm concerned.

**8.** Before or at the time of entering of this contract the second party shall have to furnish a performance security deposit of **5% of tendered amount** in form of a bank draft or Bank Guarantee, drawn in the favour of **M/s Avantika Associate Private Limited, The First Party, and payable at Dimapur, Nagaland**. The EMD of Rs. 1,40,00,000/- enclosed with the tender, shall be applied towards the Security Deposit.

The total sum of the security deposit will be retained by the AAPL, until the successful completion of this tender. The Security Money will not carry any interest. AAPL is not liable for deposition of excess Security Money. Security Money in full will be refunded back to the bidder after expiry of the tenure and satisfactory performance of the supplier throughout the period. No proportionate refund of security money will be allowed. In the event of default resulting in termination of the contract, the security deposit shall be forfeited.

9. Normally supply should be made at an average 1250-1500 pigs 80-kg to 120-kg per pig, per week. Supply should be made 3 times a week or as per requirement. Time of supply at the holding pen shall be from 7:00 am to 7:00 pm as will be instructed in the work order. There will be no separate charge provided for such deliveries. Successful Bidder will have sole responsibilities for Transportation of Pigs & Healthy Adult Pigs as per SPCA norms.
10. If the successful bidder (the Supplier) fails to deliver in accordance with one or more supply commitments within the stipulated date and time AAPL, to maintain its supply levels, may procure Pig from the open market at the risk and cost of the successful bidder & the rate difference will be charged to the Supplier and shall be recovered either from its bill and/or security money deposited with AAPL.
11. Post Delivery health certificate of animals issued by qualified veterinarian, stating that pigs are 'fit for slaughter & human consumption', should be supplied with each consignment.
12. Weight of live and healthy pigs will be taken at the time of delivery at Dimapur, Nagaland and **payment will be made on that live weight basis only.**
13. All the Payment will be made only after receiving the stock & satisfactory verification from the Pen In-Charge, Dimapur, Nagaland. No advance payment shall be allowed or made.
14. Pigs should weigh in the range of 80 kg to 120 kg. Continuous aberration from this standard range may attract penal provisions and necessary steps may be taken against the Supplier as deemed fit by AAPL.
15. If there is any dispute regarding any of the terms of this Agreement or regarding any other issues directly relating to this Agreement, the matter may first be tried to be mutually resolved by the parties failing which matter will be referred to arbitration in accordance with the Arbitration Act, 1996. AAPL shall pick the Sole Arbitrator. Arbitration venue shall be restricted to Dimapur, Nagaland. Arbitrator's decision shall be binding and final.
16. In case it becomes necessary for AAPL to temporarily suspend or postpone or extend the agreement partly or fully due to unforeseen circumstances, AAPL shall not be liable for any compensation, on account of resultant losses.



17. If the Supplier imposes conditions, which is in addition to or in conflict with the conditions mentioned herein, his bid is liable to summary rejection. In any case none of such conditions will be deemed to have been accepted unless specifically mentioned in the letter of acceptance of bid issued by the Tendering Authority AAPL.
18. INTEGRITY PACT (IP): IP is a pact between AAPL (as principal buyer) on one hand and the Supplier on the other hand stating that the two parties are committed to each other in regard to ensuring transparency and fair dealings in this procurement activity.
19. If Supplier or its agents or representatives, without AAPL's consent, has altered any animal or has substituted or added, with respect to any malpractice, Suppress the real facts or quality control standard or any procedure set forth in this Agreement or any exhibit hereto are not called for thereby (provided that, for avoidance of doubt, no cure period shall be required prior to termination under this provision).
20. **Confidentiality.** (a) "Confidential Information" means this Agreement and all confidential or otherwise proprietary business and technical information relating to the Parties and their respective businesses, including, without limitation, ideas, know-how, trade secrets ( policy , rearing ,medication & Vaccination ) sales techniques, financial statements and data, sources of supply, advertising, actual and prospective customers, pricing, costing, and accounting procedures. Each Party agrees to maintain the Confidential Information in strict confidence and, except to the extent expressly permitted in this Agreement or otherwise consented to in writing by the other Party, that the Confidential Information will not be disclosed by it or its "Representatives" (defined to include affiliates, directors, shareholders, officers, employees, agents, subcontractors, consultants, members, managers, advisors, or other representatives including legal counsel, accountants and, in the case of Customer, its Distributors) to any "Person" (defined to include individuals, partnerships, companies, limited liability companies, entities, corporations, or agents thereof) except with the specific prior written consent of the other
21. **Force Majeure:** If at any time during the currency of the order / agreement, it becomes impossible on the Supplier on account of lawful strike and lockouts, riots, civil commotions, epidemic, pestilence, earthquakes, fire, storm or flood or any other act of God or Government, to continue with the execution of the supply contract, then during the continuance of such contingency the supplier may not be bound to execute the contract as per order / agreement / contract. The supplier shall, however, immediately inform AAPL by registered post about such acts and occurrences, duly certified by the local Chamber of Commerce, at the beginning and end of the above causes of delay and such force majeure conditions. The supplier shall resume their supply once the restrictions has been removed/lifted/ended.

22. Supplier shall maintain commercial general liability for bodily injury or death to any person or persons and loss or damage to any property. A certificate of such insurance coverage shall be furnished to AAPL upon execution of this Agreement and thereafter upon request.

23. **Inspection of the Source Farm:** Source Farms may be inspected by the authorized persons of AAPL as and when required basis as the inputs (Animals Data) are the critical means of verification for AAPL. AAPL reserves the right for inspection/verification/checking of Data Sheet, Agreement copy in between Farmer(s) & Supplier , Farmers' payment sheet/records , Records related to Vaccination/Medication/Feed distribution (intake/consumption/left over), Lifting procedure at any time in presence /absence of Supplier.

**24. Submission of Bill:**

Bill should be submitted in duplicate along with original / copy of receipted challan and original weighment certificate of the plant / certified by the concerned officer of the plant. Bill should be supported by Item-wise , date-wise , batchwise supply report supported by Health Fitness/ante-mortem certificate The payment will be made within 7-15 working days , counted from the date of submission of proper bill complete in all respects. AAPL will not take any responsibility for the wrong / disputed bills and the bill/s, which are not in proper order.

25. **Penal Measure:** The earnest money deposit furnished by a firm will be liable to be forfeited in full (Including excess amount of earnest money, if deposited), if the firm withdraws tender as a whole or for any particular item at any stage during the tenure of tender or fails/refuses to enter into written agreement once the rate for any/all items(s) is/are accepted within the time specified when requested to do so by AAPL and/or refuses to deposit security money. Such firms offer will not be taken into consideration in future & shall liable to be black listed for 3 (three) years.

The security money deposit furnished by a bidder is liable to be forfeited in full (including excess amount of security money, if deposited) along with cancellation of order without prejudice in the event of failure/refusal to maintain the supply schedule and/or non-observance of terms & conditions of tender and/or contracted specification and/or quality/quantity and the authority will be at liberty to terminate the contract as a whole or part. In consequence of submission of false or fabricated documents by any firm/ company for participating in the tender, if proved later, shall be liable to be Black Listed for 3 (three) years.

26. **Dispute resolution:** Any dispute arises out of this contract the matter may first be tried to be mutually resolved by the parties (AAPL and the successful offeror who will get the contract) amicably, failing which the matter will be referred to a sole arbitrator for binding arbitration in accordance with the Arbitration and Conciliation Act, 1996. The sole arbitrator will be selected by AAPL and the venue shall be Dimapur, Nagaland. All matters in respect of this contract will come under the jurisdiction of the Guwahati High Court.




